CPA Unique Features and Background information

- 1 Four of Mattapoisett board is elected. This is not the case in many towns.
- 2 CPA money can be awarded to both Town projects or private projects so long as they meet the requirements of the law.
- 3 CPA money can be used to incur debt. We presently have 2 bonds out. 1 is for a piece of land purchased the Water Department to protect well #5 the other is for the Holy Ghost property.
- 4 If the town was ever to vote to end CPA we would continue to have to assess cpa money until the debts were paid off.
- 5 The law requires the town to have a CPA plan for administrating its funds. We spent just about a year developing ours. We researched other communities plans, held 4 public meetings one on each category, looked over the town's master plan and open space & recreation plan met with the Selectmen and worked many nights on putting it all together.
- 6 Mattapoisett accepted the exemption for seniors and low income families so that the first \$100,000 of the assed value of their houses are not included in the 1% surcharge.
- 7 Town meeting can accept, reject or reduce the amount of funding. It can not increase the amount of funding recommended by the committee
- 8 Property taxes traditionally fund the day-to-day operating needs of safety, health, schools, roads, maintenance, and more. But until CPA was enacted, there was no steady funding source for preserving and improving a community's character and quality of life.

 The Community Preservation Act gives a community the funds needed to control its future.

HIGHLIGHTS

- 1 Preserved historic town records and the original road layout maps in the Town Clerks office
- 2 Helped to preserve and catalog over 20,000 historical artifacts and records at the Historical Society helping the society in creating a computerized data base that will eventually be on line to the public
- 3 Helped to rebuild and preserve the historical clock system and the historic Henry Huttleston Rodgers plaque at Center School
- 4 Provide part funding for the preservation of the historic Friends meeting house in east Mattapoisett
- 5 Helped fund repairs to the Town Beach bath house and the Town wharves
- Repaired the Hammond street tennis courts and make improvements to the area for the recreational benefit of town residents.
- Purchased the Holy Ghost property on Park street, to protect a unique property for future active recreational activities, as identified in the Town's open space and recreation plan.
- Protected 832 acres of open space for protecting the towns water supply, unique environmental features and areas of critical environmental habitat that also can be used for passive recreation
- 9 Combined funds with the Fairhaven CPA committee, The Marion CPA Committee, The Mattapoisett River Valley Drinking Water Protection District, Mattapoisett Land Trust, Private Funds, Buzzards Bay Coalition State and Federal grants on a variety of projects
- Spent approximately \$1.4 million in CPA funds which leveraged an additional \$8.75 million in outside funding not counting future \$12 million in federal funding for Bike Path.

Towns with a 2% surcharge receives a 17.2 % Match
