DOT / D.W. White Status: Phase 1B

- The boardwalk decking was installed on site over the summer. D.W. Whites subcontractors have installed most of the black top and fencing.
- Received email in the spring from Ted Nolte, AIA relative to cutting of trees on his property near the western approach to the Mattapoisett River Bridge. His property is at 9 Locus Street. We had a meeting on site, and Stephen is looking into making a planting plan for that area with DOT with the possibility of working with the Mattapoisett Garden Club and the Tree Committee. There isn't any landscape plan in DOT's documents. Mike Immel, LA (retired) has offered to help with the landscaping.
