PUBLIC HEARINGS:

Request for Determination of Applicability filed by Fairhaven Board of Public Works. The address is 29 Tinkham Lane as shown on Assessors' Map # 24, Lot # 10. The Applicant proposes the installation and development of an 18" x 24" gravel packed replacement well. Minor filling will occur to allow for construction extension of the existing fence around the new well. *The Representative is Patrick O'Neale from Tata & Howard, Inc.*

Request for Determination of Applicability filed by Mattapoisett Water & Sewer Department. The address is Fairhaven Road at the intersection of River Road. The project consists of abrasive blast cleaning and painting the structural steel supporting the water main over the Mattapoisett River. Work also includes replacement of the structural steel cross member bolts and minor welding of surface defects. The Representative is Patrick O'Neale from Tata & Howard, Inc.
