**This project is continued until the 7/25/16 meeting. Continued Request for Determination of Applicability filed by Forrest Neal.** The address is 16 Brandt Island Road as shown on Assessors' Map # 11, Lot #14. The applicant proposes construction and placement of an 8' x 15' windowless shed.

**Continued Request for Determination of Applicability filed by John Schmid.** The address is 4 Justin Avenue as shown as on Assessors' Map # 2, Lot # 61. The applicant proposes construction and placement of an 8' x 16' shed.

**Continued Request for Determination of Applicability filed by Dennis Arsenault.** The address is Snow Fields Road as shown on Assessors' Map # 28, Lot # 26. The applicant requests that the Conservation Commission confirm the boundary of a delineated Bordering Vegetated Wetland as flagged by Mark Manganello of LEC Environmental Consultants, Inc.

The proposed project involves construction of an elevated single-family dwelling, associated pervious driveway, utilities, filling, grading and wetland replication. **SE44-1277 Continued Notice of Intent filed by William & Annemarie Fredericks.** The address is 30 Holly Woods Road as shown on Assessors' Map # 2, Lot # 180A. The applicants propose to construct a new 10 ft. wide circular driveway in front of their home, completely within the lawn area. The grade in front of the home will be lowed with low, stone retaining wall constructed between the new driveway and home. A new walk will also be constructed. Approximately 1 acre of upland is proposed to be cleared, grubbed and seeded for agricultural purposes. Animal fencing shall be installed along the limits of the wetlands and lot lines. The agricultural activity shall follow the USDA Conservation Plan submitted. It is to be notes that some cutting has occurred at the site at the site under their Forestry Management Plan. The engineer is Doug Schneider from N. Douglas Schneider & Associates.


