ARTICLE 1: ELECTED OFFICERS' COMPENSATION

ARTICLE 2: GENERAL OPERATING BUDGET

To see if the Town will vote to appropriate the sums of money to defray general operating expense of the Town for Fiscal Year 2021 including debt and interest, the money to be raised by taxation, borrowing or transfer from available funds, or take any action relative thereto.

ARTICLE 3: FUNDING TO REDUCE OPEB LIABILTY

To see if the Town will vote to appropriate the sum of \$250,000 from the Tax Levy for the purpose of contributing to the Town to Mattapoisett Other Post Employment (OPEB) Trust Fund said funds to be used for the purpose of future costs or take any action relative thereto.

ARTICLE 4: FIRE STATION DEBT REDUCTION

To see if the Town will vote to appropriate the sum of \$150,000 dollars from the Town of Mattapoisett Debt Stabilization Account for the purpose the Fiscal 2021 annual principal and interest payment for the fire station project or take any action relative thereto.

ARTICLE 5: DEPARTMENTAL REVOLVING FUND AUTHORIZATION

To see if the Town will vote, in accord with MGL c.44, §53, to amend Section 27.1 of the Town Bylaws, Revolving Funds, to add the two new revolving funds to the Bylaw, and further, to amend the chart set forth in Section 27.2 of the Town Bylaw to set expenditure limits for such new revolving funds for the Fiscal 2021 year, with such expenditure limits to apply from year to year unless amended by Town Meeting prior to July 1 in any fiscal year, or take any action relative thereto.

ARTICLE 7: WATER AND SEWER RESERVE ACCOUNTS

To see if the Town will vote to appropriate the sum of \$20,000, with \$10,000 to come from Water Retained Earnings and \$10,000 to come from Sewer Retained Earnings, for the purpose of establishing Reserves, respectively, for unforeseen expenses of each Department in FY2021, or take any action relative thereto.

ARTICLE 8: ALLOCATION OF REVENUES COMMUNITY PRESERVATION ACT (From Community Preservation Funds)

To see if the Town will vote to hear and act on the report of the Community Preservation Committee on the Fiscal Year 2021 Community Preservation Budget, and to appropriate or reserve from the Community Preservation Act, Fiscal Year 2021 estimated annual revenues to meet the administrative expenses and all other necessary and proper expenses of the Committee for Fiscal Year 2021 and reserve for future appropriation from said annual revenues a sum of money for open space including recreation, historic preservation and community housing purposes, as well as a sum of money to be placed in the FY2021 Budgeted Reserve all as recommended by the Community Preservation Committee as follows;

ARTICLE 9: AUTHORIZATION OF USE OF GRANT ANTICIPATION NOTES FOR TOWN PROJECTS

To see if the Town will vote to authorize the various town departments to use Grant Anticipation Notes for any grant funding that they are in receipt of notice of award, and have a signed executed contract between the Town and the Commonwealth of Massachusetts and Mattapoissett, further to authorize the Treasurer with the approval of the Board of Selectmen to use Grant Anticipation Notes for the purpose of funding, with reimbursement from the Commonwealth for expenditure of the grant funding, or take any action relative thereto.

ARTICLE 10: INDUSTRIAL DRIVE CONFIRMATORY TAKING – EASEMENT

To see if the Town will vote to authorize the Board of Selectmen to take all necessary actions to acquire by gift, purchase or eminent domain an easement for a public way, and for all municipal and other purposes reasonably related thereto in, over, and through certain land, within the current layout of Industrial Drive in the Town of Mattapoissett, Massachusetts, said parcels and layout being more specifically shown a certain plan of land entitled "Transportation Improvement Project, Plan and Profile of North Street/Industrial Drive in the Town of Mattapoissett, Plymouth County – Final Design, by The Engineering Corp. dated April 29, 2020 as amended, a copy of which is on file with the Mattapoissett Town Clerk's Office And, since damages have been previously awarded to the owners of each parcel over which an easement is taken hereunder by certain previous Takings, to award \$1.00 to the owner of each property over which an easement is taken hereunder for a total award of \$14.00 to be paid from the Tax Levy; or to take any other action thereto.

ARTICLE 11: ACUSHNET ROAD BRIDGE IMPROVEMENT EASEMENTS

To see if the Town will authorize the Board of Selectmen to take all necessary actions to acquire public way easements, slope easements, drainage easements, public utility easements and temporary construction easements through all legal means including by eminent domain pursuant to General Laws Chapters 79 and 82, by purchase, or by donation, for the reconstruction and improvement of the bridge by which Acushnet Road crosses over the Branch of the Mattapoissett River, and for all municipal and other purposes reasonably related thereto, within, over, and through certain land in the Town of Mattapoissett, Massachusetts, in the locations shown on a certain plan of land entitled "Plan of Easements at Acushnet Road Over Branch of Mattapoissett River" Dated January 21, 2020 by Field Engineering and GPI Engineering on file with the Mattapoissett Town Clerk, and, to raise and appropriate, transfer from available funds, or otherwise provide a sum of money for such acquisition and all costs incidental and related or take any action relative thereto.
