QUESTION #1: Shall the Town of Mattapoisett amend its acceptance of sections 3-7 inclusive as approved by its legislative body and summarized below? Summary: This question involves amendment of the Town's acceptance of G.L. c.44B, §§3-7, also known as the Community Preservation Act (the "CPA") to adopt an additional optional exemption. At the 2006 Annual Town Meeting, the Town voted under Article 16 to adopt the CPA, approved a surcharge of 1% and adopted the optional exemption for the first \$100,000 of the value of each taxable parcel of residential real property in the Town, and this was approved by ballot by the voters. The Annual 2009 Town Meeting voted to accept an additional exemption from the CPA for property owned and occupied as a domicile by a person who would qualify for low income housing or low or moderate senior income housing in Mattapoisett.
