



REGULATIONS FOR WEDDING CEREMONIES OR OTHER NON-TOWN SPONSORED SOCIAL FUNCTIONS AT SHIP YARD OR VETERAN'S PARKS

- 1.) A non-refundable fee of \$100.00 is required for any wedding, or non-town sponsored social function that is to take place at either Ship Yard Park or Veteran's Park. All requests must be put in writing and submitted, along with the \$100.00 fee to the Selectmen's Office to reserve your date.
- 2.) ***NO alcoholic beverages are allowed at Ship Yard Park or Veteran's Park.***
- 3.) Decorations are allowed in Ship Yard Park and Veteran's Park. All decorations must be removed once a ceremony or event is over and the premises must be left the way in which they were found.
- 4.) Parking is available at Veteran's Park. For weddings or non-town sponsored social functions at Veteran's Park with 100 more guests you must notify the Mattapoisett Police Department to inform them of the number of vehicles to be parked there. Parking at Ship Yard Park is for residents only. When using this area you must use side street parking or inquire with the Selectmen's Office for alternative parking information. The Village area is limited for any extra vehicles. A limousine or any similar type of vehicle is allowed to come through Ship Yard Park parking area to drop off members of a wedding party.



Release of Claims, Indemnity and Hold Harmless Agreement

I, _____, in consideration of my use of Ship Yard Park or Veteran's Park for a wedding or other non-town sponsored social function, and for other good and valuable consideration hereby acknowledged, do hereby agree to forever RELEASE the Town of Mattapoisett, its employees, agents, officers, volunteers, or contractors (the "Releasees") , from any and all claims, actions, rights of action and cause of action, damages, costs, loss of services, expenses, compensation and attorneys' fees that may have arisen in the past, or may arise in the future, directly or indirectly from known and unknown personal injuries which I or my guests, employees agents, successors or assigns may have as the result of my use or the use of my guest, employees or agents of Ship Yard Park or Veteran' s Park in the Town of Mattapoisett, and all activities related thereto.

I further promise, to INDEMNIFY, REIMBURSE, DEFEND, and HOLD HARMLESS the Releasees against any and all legal claims and proceedings of any description that may have been asserted in the past, or may be asserted in the future, directly or indirectly, including damages, costs and attorneys' fees, arising from personal injuries to myself or others or property damage resulting from my use, or the user of my guests, employees or agents, of Ship Yard Park or Veteran's Park.

I hereby further covenant for myself, my successors and assigns not to sue the said Releasees on account of any such claim, demand, or liability.

I am fully aware that by signed this document, I am releasing the above mentioned parties from liability that may arise as a result of intentional or negligent acts of these parties. Additionally, it is my intent to release the above mentioned parties from liability and defend and indemnify said parties for liability relating to any accident and resulting injuries and/or death that may occur as a result of my use, or the use of my guests, employees or agents, of Ship Yard Park or Veteran's Park.
